Shoppes at Tanglewood's current tenant roster includes national, regional and local tenants, such as: Jersey Mikes Subs, Sally Beauty, The Athlete's Foot, GameStop, Hair Cuttery, 252 Tobacco & Vape, Volcano Japanese and Grace Montessori School. It also features a highly visible shared entrance with Walmart at the signalized intersection of Halstead Ext. and Tanglewood Parkway, which sees approximately 22,000 vehicles per day.
